The appointee(s) shall report to the office of the Director General, Stationery & Office Supplies, Srinagar within a period of twenty one (21) days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Matriculation/Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vi. Relevant Category Certificate (in case candidate belong to the Reserved Category).

The appointment of the appointee(s) shall further be subject to the following conditions:-

- i.** If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee(s) for appointment as Class-IV shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the appointee(s).
- ii.** The candidates shall furnish an undertaking in the shape of affidavit to the following effect:-
 - c)** If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee(s) for appointment as Class-IV shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the appointee(s).
 - d)** That the appointee(s) have no criminal records and also not facing any criminal proceedings in any Court of Law.
- iii.** The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory report in respect of qualification/other certificates as well as final CID verification are received from the concerned authority.
- iv.** All these appointments shall be made in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2021.
- v.** The appointments of the candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- vi.** The appointee(s) shall be initially on probation for a period of two (02) years.
- vii.** The Cadres/Departments allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
- viii.** The appointments shall be cancelled ab-initio, if it is found that the candidates is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- ix.** If the candidates fails to join within a period of twenty one (21) days from the date of issuance of order they shall forgo right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.




- x. The inter-se-seniority of the appointee(s) shall be strictly as per their merit in the selection list.
- xi. All the appointment orders shall be issued subject to outcome of any petition(s) pending in any competent court/Tribunal etc.
