In continuation of Government Order No. 32-JK(ARI & Trgs) of 2022 dated 29.10.2022 and 02-JK(ARI & Trgs) of 2023 dated 16.01.2023 and on the recommendation of Service Selection Board, sanction is hereby accorded to the appointment of **Mr. Sabzar Ahmad Malik S/o Abdullah Malik, R/o Chahihal, Tehsil Banihal, District Ramban as Multitasking Staff (Orderly) under RBA Category** in the Government Press Jammu, in pay Level of SL-1 (14800-47100), with immediate effect:

The appointee shall report to the office of the General Manager, Government Press Jammu, within a period of twenty-one (21) days from the date of issuance of this order failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled *ab-initio* without any further notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- 
- i. Academic/Qualification Certificates.
 - ii. Matriculation/Date of Birth Certificate.
 - iii. Health Certificate from the concerned Chief Medical Officer of the District.
 - iv. Domicile Certificate issued by the Competent Authority.
 - v. Valid relevant Category Certificate, if any applicable.

The appointment of the above candidate shall further be subject to the following conditions:

- a. The appointee shall furnish an undertaking in the shape of affidavit as per Annexure-A to this Order.
- b. The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory report in respect of genuineness of Qualification/Date of Birth/Relevant Category certificates.
- c. The appointee shall be on probation for a period of two (02) years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e. The inter-se-seniority of the appointee shall be strictly as per their merit in the selection list and J&K Civil Service (Classification, Control and Appeal) Rules, 1956.
- f. The appointments of the above appointee shall be cancelled *ab-initio*, if it is found that he possesses higher qualification than the prescribed one at any stage and she shall also be liable for criminal prosecution under law.
- g. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before competent court of law.
