**Subject:** Minutes of the meeting of Designated Committee constituted vide Government Order No. 35-JK (ARI&Trgs) of 2024 dated 11-09-2024 under the Jammu and Kashmir Rehabilitation Assistance Scheme-2022 read with S.O. 397 of 2024 dated 16-08-2024.

A meeting of the Designated Committee was held on 07.01.2025 at 3.00 P.M under the Chairmanship of Shri Pankaj Gupta, JKAS, Special Secretary to the Government, Department of Administrative Reforms, Inspections and Trainings (Nodal Officer for RAS in ARI & Trgs Department) in his office chambers (Room No. 1/36, Mini Block, Civil Secretariat Jammu) to assess, consider and recommend the Rehabilitation Assistance Scheme (RAS) cases.

Besides above, Mr. Parshotam Sharma, General Manager, Ranbir Government Press (Welfare Officer) and Mr. Sajjad Khan, Incharge Manager, Government Press, Srinagar also attended and assisted the Committee.

**Proposal:**

To assess and consider the application of Mr. Trikal Darshi S/O Late Sh. Chaman Lal Gul, DTP operator, Ranbir Government Press, Jammu for compassionate appointment under RAS-2022.

**Deliberations:**

At the outset, the Under Secretary to the Govt., apprised the Chair that the GAD has forwarded one case of RAS-2022, vide its O.M. No: GAD-RAS/2/2024-09-Part(4) (7587602) dated: 22-10-2024, to ARI & Trainings Department and with the request to dispose of the case for compassionate appointment of Mr. Trikal Darshi S/O Late Sh. Chaman Lal Gul, DTP operator, Ranbir Government Press, under RAS-2022, who has submitted online application form for seeking appointment on compassionate grounds. Thereafter, the case was forwarded to concerned Welfare Officer (General Manager, Govt. Press, Jammu) to examine the case and furnish the requisite information in terms of SO 429, Dated:06-09-2022 read with SO 397 dated: 16-08-2024. In response, the Welfare Officer has examined the case and submitted the requisite information after authentication and verification of the documents through the concerned DDO for its placement before the designated committee constituted for the purpose.



It was further informed to the meeting that the applicant namely Trikal Darshi has applied for seeking the compassionate appointment through online portal within one year from the date of death of his father and the applicant is dependent family member of Late Sh. Chaman Lal Gul. The requisite documents of the applicant i.e. Qualification Certificate (Marksheet of 10<sup>th</sup> and 12<sup>th</sup>) and Domicile Certificate reveals that he is eligible and suitable for the post of MTS under the provisions of relevant recruitment rules.

Meanwhile, the Chair enquired that whether the applicant has submitted all the formalities and undertakings as mentioned in the SO 397. In response, the Committee members scrutinized all the relevant documents/certificates associated with the case and found them in order.

Moreover, on assessing the applicant with regard to the Relative Merit Points Assessment Scheme (RMPAS) on a 100 point scale, it came into forth that the applicant score is 21 out of 100.


### Decisions:


After threadbare discussion on the issue, following decisions were taken in the meeting:


1. The case of the applicant namely Mr. Trikal Darshi S/O Late Sh. Chaman Lal Gul is complete in all aspects and he is eligible for the Compassionate appointment under RAS-2022 against the vacancies earmarked for the said purpose.
2. The Committee recommends the department/Competent Authority to consider the compassionate appointment of Mr. Trikal Darshi S/O Late Sh. Chaman Lal Gul, against the post of class-IV / MTS vacancies identified in the Ranbir Govt. Press, Jammu in terms of Jammu and Kashmir Rehabilitation Assistance Scheme, 2022 amended vide SO 397 of 2024 dated: 16-08-2024. However, before considering his appointment, pre-appointment character & Antecedent Verifications shall be conducted as per the procedure prescribed for the purpose.
