Sanction is hereby accorded to the constitution of Committee for rolling out of Action Plan for solarization of Government Buildings in respect of ARI & Trainings Department with the following composition:

1. Director Finance, ARI & Trainings Department	Chairman
2. Special Secretary, ARI & Trainings Department	Member Secretary
3. General Manager, Government Press Srinagar/Jammu	Member
4. Representative of JAKEDA	Co-opted Member
5. Representative of DISCOM	Member

The terms of reference of the committee shall be as under:

1. The Committee shall monitor and supervise the mission of solarization of all Government Buildings in respect of ARI & Trainings Department for accelerated solarization to attain saturation by or before December, 2024 as directed by the Prime Minister's Office (PMO).
2. The Committee shall advice on innovative ways for resource mobilization for successful implementation of the project in RESCO/Capex/Hybrid modes. They shall suggest source of funding through Finance Department/MNRE and other Funding Agencies like REC/other Financial Institutions.
3. The Committee shall recommend decisions regarding the RESCO tender and identification of executing agencies.

4. The Committee, after viability shall collect all major parameters like availability of rooftop and evacuation network, the total electricity load, sanctioned connected load as well as revenue budget spent on electricity bills be shared with JAKEDA.
5. The Committee shall nominate Estates Officer/In-Charge Officers for Buildings where RESCO/Capex/Hybrid mode shall be implemented.
6. The Committee may hire Consultants/Technical Advisors for suggestion any initiative(s) required for acceleration of the solarization of the identified Government Buildings.
7. The Committee shall appraise the Administrative Department about the progress of the solarization, so that same is shared on fortnightly basis with the Science and Technology Department/JAKEDA.
